  Insurance Plan, this is unlikely to happen. Cost would be disastrous. NFC is not
  supportive of this unless the State would help fund.
- Dual Enrollment funding issues and challenges
- o Invited Lynn Wyche to discuss Sentinel Fest (Oct. 18-19). Would like trustees to join us tomorrow. Thanked the Board for their support.

#### **ATTORNEY TIME**
